## Administrative Monthly Report .... Monday December 14, 2020

### Easement Status:

Property LLL.3 (104.722 ac): County Commission approval for the easement is scheduled for December 17, and the closing is scheduled for 1PM on December 22.

FY 20 easement applications:

- Property KD01 (302 ac). Landowner wishes to amend their counter-offer. Survey and baseline have been ordered.

FY21 Applications:

- NRCS: Board acceptance/offer letters sent to the two approved applications HFD02 and KD02.
- ABPP: ABPP staff James Modrick on 12/10/20 emailed to say that the Printz property is being considered for funding.

NRCS has not announced the FY21 application deadline or provided the final application matrix as of December 14, 2020. I expect the delay to continue until the federal spending bill passes.

### Projects in process:

Working with Berkeley FPB on a proposal for an easement monitoring contractor for both counties. Concept discussed with Potomac Conservancy on 10/16. We are preparing a proposal for Board review.

Easement review: Twelve easements so far contain errors, some more complicated to resolve than others. Grant Smith has reviewed the proposals for correction or amendment on co-held easements.

Procedures manual: As part of the succession planning, this is an on-going project to document the various procedures for running the Farmland Protection Program.

Annual Report: The content and photographs are in design. I am drafting a cover letter.

Forestry Policy Review – Easement Committee will take this up in January.

<u>Fall Monitoring</u>: 23 property visits were scheduled over 5 days between October 30 to November 20. Monitoring reports were completed, reviewed by Easement Committee. We are waiting for LTEP to sign off on the reports for properties they lead.

### Administrative:

Donation: We received \$2,500 (total) from two repeat donors.

Attorney services: Our current attorney has not been delivering what we need in a timely manner. I still have no alternatives.

Financial: Russ Quinn confirmed he will help with planning. The Board needs to consider financial plan to reach its goal of 20,000 acres by 2030, the need to budget for a stewardship endowment and easement insurance (Terrafirma), and a stewardship contractor to conduct annual monitoring.
