MEETING MINUTES

Call to order by President McDonald at 5:00 pm. Attending were Mr. Glenn, Ms. Tabb, Mr. Kercheval, Mr. Ober and Ms. Wheeler.

Mr. Glenn acted as secretary in the absence of Mr. Quinn, Secretary.

Approval of minutes of previous meeting. Adopted by Unanimous consent.

Treasurer's Report. Review Ms. Wheeler reviewed with the Board in the absence of the Treasurer, Mr. Reisenweber. Discussion among Board members regarding amounts in various accounts and purposes of accounts. Mr. Kercheval moved to adopt the Report. Mr. Ober seconded. Motion adopted on voice vote without objection.

Administrator's Report. Ms. Wheeler updated the directors on various matters.

Unfinished Business.

With regard to Olcott amendment, Ms. Wheeler recommends to monitor the property in lieu of amendment.

New Business.

Consideration of FY2014 Applications for funding and NRCS matching funds.

Members of the Easement Committee reported to the Board regarding FY2014 Application Ranking sheet dated January 13, 2014. Committee found no mistakes in the technical allocation of the points to the 2014 applications based on the Board's ranking sheet.

With respect to applications for individual properties, the Committee's report is summarized as follows:

ZZ: no issues

AAA: Question on per acre price

BBB: Technically a high ranking property but has a pipe stem in it.

YY: doesn't have water or historic, abuts historic and is ABPP battlefield.

WW: no issues

XX: no subordination agreement with application

UU: no subordination application, no agricultural use with application

Easement Committee reported that XX and UU were nonconforming applications.

Easement Committee noted that both XX and UU applicants had not provided a subordination agreement from the secured lender on each of the properties. Ms. Wheeler presented a letter from counsel opining that an express subordination agreement must be obtained from each secured lender on an easement property as a condition of closing.

Discussion of how many applications should be considered for 2014 funding.

Discussion of whether just funding ZZ and AAA is appropriate to preserve funds for next fiscal year.

Easement Committee confirmed that the 2014 rankings are correct technically but the Committee has strong reservations about the BBB application and the use of pipe-stemming to achieve higher point values, potential pollution issues if 10 acres of exclusion area is developed for fertilizer storage and issues regarding monitoring.

Mr. Kercheval moved to accept ZZ application and submit to NRCS for funding match. Seconded by Ober. Motion adopted by unanimous voice vote.

Mr. Kercheval moved to accept AAA and submit to NRCS for funding match subject to negotiation of acceptable purchase price not to exceed \$6,500 per acre. Seconded by Mr. Ober

Motion adopted by unanimous voice vote.

Mr. Glenn moved that the Board adopt the Easement Committee's report finding that Applications XX and UU are non-conforming and that the Administrator be authorized to advise the applicants that their applications will not be considered on that basis. Motion seconded by Mr. Kercheval. Motion adopted by unanimous voice vote.

Mr. Glenn moved that the Board remand the balance of the applications to the Easement to Committee to hold pending final approval of Applications of AAA and ZZ. Mr. Ober seconded. Motion adopted by unanimous voice vote.

President adjourned the meeting. 7:00pm
