- Mr. Perry, with input from other board members proposed the following motion:

The JCFPB to increase the salary of the Executive Director, Ms. Wheeler by 7.5% above her current salary, effective from her last performance review on **September 21, 2021**. Ms. Wheeler's hire date was <u>February 11, 2011</u>. The increase is due to Ms. Wheeler's promotion from a County Grade 4 employee to a County Grade 7 employee.

Staff of the JCFPB to receive the same cost of living adjustment as other other County's employees and at the same time.

Annual performance reviews and salary increases for the staff of the JCFPB will be carried out and determined by the JCFPB, with input from the County Administrator and with consideration of the county's compensation marker for the specific year. The JCFPB's timetable for these activities will match the County's.

- Mr. Glenn seconded the motion.
- The motion was approved by unanimous consent.
